Keynote Speaker: Bernard Lafayette Jr.



# CRISIS CARE CENTER WALLBREAKING EVENT RECAP

Community Mental Health Authority of Clinton, Eaton, and Ingham (CMHA-CEI) counties held a wall-breaking ceremony on Monday, November 25, 2024 celebrating the coming transformation of the former McLaren Greenlawn campus into a new crisis stabilization center.

Remodeling is expected to take about a



year and then the new crisis care center will open on Lansing's south side.



"Our community deserves more behavioral health support, and the Crisis Care Center is a critical resource that reflects our collective vision for a healthier, more compassionate future," -Sara Lurie, CEO of CMHA-CEI."

The ceremony was attended by many dignitaries who voiced their strong support for the initiative, including Mayor Andy Schor, Senators Debbie Stabenow and Sarah Anthony, MDHHS Director Elizabeth Hertel, COO of McLaren Health Care, Jay de los Reyes, NAMI Lansing President Katreva Bisbee, Ingham County Sheriff, Scott Wrig-



glesworth, CMHA-CEI Board member and Ingham County Board of Commissioners, Ryan Sebolt and Rep. Angela Witwer. Their messages underscored the urgent need for resources like the Crisis Care Center to address behavioral health challenges in the community.

# CRISIS CARE CENTER WALLBREAKING EVENT RECAP

The ceremonial wall-breaking was both a symbolic and tangible moment of progress, signifying the beginning of a new chapter for the building and for the community. Attendees also participated in a community engagement activity, sharing insights and ideas to help shape the branding and vision for the Crisis Care Center, reinforcing the inclusive and collaborative spirit behind this initiative.

The center will expand services for those facing behavioral health issues. Offering immediate care, expert care 24/7, counseling, assessments, and treatments. With continued care and resources outside the facility. This will also help reduce emergency room visits that aren't equipped to handle mental health issues and reduce arrests of those who act violently during a crisis.

The Consumer Advisory Council is recruiting new members. If you would like to have an opportunity to help improve our services and share your voice with lived experiences or advocate for individuals with mental illness, substance use disorder (SUD) and/or intellectual and developmental disability (CSDD). The council gives you the opportunity to meet with members of the Board of Directors and the CEO, Sara Lurie, as well as the chance to meet staff from



various departments. The council has provided input on a variety of topics.



The council has participated in focus groups for the development of the upcoming Crisis Service Unit (CSU), provided input in making the Jolly Road lobby a welcoming environment and assisted in the renaming of the department that provides substance use services. The council also participates in advocating for behavioral health services, and stays up to date with legislation. Members

are made up of consumers and/or family members who are currently receiving or have received services from CMHA-CEI and live in Clinton, Eaton or Ingham Counties. The council requires a two-year commitment and members receive compensation for attending the meeting.

If you or anyone you know have an interest in becoming a member, consider attending a meeting. The CAC meets monthly on the 1st Thursday of the month from 3:30 pm to 5:00 pm via phone or Zoom.

# The 988 SUICIDE & CRISIS LIFELINE

The 988 Suicide & Crisis Lifeline (formerly known as the National Suicide Prevention Lifeline) is made up of an expansive network of over 200 local and state funded crisis centers located across the United States. When people call, text, or chat, they will be connected to trained counselors that are part of the existing Lifeline network, who can help, listen, offer support, and provide resources if needed.









If you, or someone you know, are having thoughts of suicide, or experiencing a mental health or substance use crisis, call 988 for compassionate help.

The 988 Suicide & Crisis Lifeline is available 24/7 and is free and confidential.

The Veterans Crisis Line is for any Veteran, service member, and their families. They can help even if you're not enrolled in VA benefits or health care.

Behavioral Health Screening, which includes mental health, substance use, and more, is a key instrument in assessing your overall well-being.


