Call to Order:

The meeting was called to order by Chairperson Joe Brehler at 5:30 p.m.

Previous Meeting Minutes:

Expense Contract Renewal: Community Based Interventions Rehabilitation Services, Inc. (CBI Rehabilitation Services, Inc.)

Gwenda Summers noted that the recommendation has the accurate per diem rate of \$289.46.

MOVED by Raul Gonzales and SUPPORTED by Dave Pohl that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to enter into a new contract with CBI Rehabilitation for respite care services, for the amount of \$633,919.37 (\$289.46 per diem) per year for the time period of October 1, 2019 through September 30, 2020.

Revenue Contract Lease Renewal: Affiliated Health Services Inc. Ascension Michigan Pharmacy

John Peiffer noted the large increase in square feet in the new pharmacy. This revenue contract renewal is for Ascension Pharmacy to pay CMHA-CEI \$40,500 for a period of three years beginning October 1, 2019 and ending September 30, 2022.

Expense Contract Lease Renewal at 3500 S. Cedar Street, Suite 116

This lease renewal is with Everett Plaza Associates, LLC. CMHA-CEI will pay \$51,039 in consecutive monthly installments for a period of five years beginning November 1, 2019 and ending October 31, 2024.

Equipment Copier Lease / Expense Contract Renewal: Ricoh Copiers

This equipment lease is with Ricoh USA, Inc., for CMHA-CEI to lease copiers and pay \$1902.08. per month for 48 months or \$22,836.96 annually for the period of October 1, 2019 through September 30, 2023

Revised Program Proposals to Balance FY 2020 Budget

Stacia Chick told the committee CEI has received figures from MSHN, and they are about \$2.2M below what was predicted. She said that in the past, CEI has amended

budgets to match MSHN's, but in the last few years, CEI has lapsed back additional funds to MSHN when their revenue projections were off. Stacia asked the committee if they would like to assume MSHN's projections or CEI's own revenue projections. Stacia noted if we do not reduce the budget, she will be looking at revenue every month to gauge the revenue coming in and adjusting accordingly.

Joe said we should keep the budget projected internally. Dave agreed with this proposal. Joe asked "What was the average dollar amount lapsed over the past five years?" Stacia said four to seven million dollars, on average. Her suggestion is to continue with CEI's internal budget projections.

Stacia said that CEI is projected to lapse about \$4 million this year, for which she brought proposals to the committee previously. She received advice from legal consult to increase the contributions to MERS by two million dollars.

MOVED BY Kay Randolph-Back and SUPPORTED by Dave Pohl that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, Ingham Counties Board of Directors approves an additional two-million dollar payment to MERS for fiscal year 2019.
