Expense Contract Renewal: IRIS Telehealth

This contract renewal is for purchasing telepsychiatry services for the period of October 1, 2020 to September 30, 2021 and pay \$125-200/hour, depending on provider(s) selected, for those services.

Revenue Contract Renewal: Sparrow Family Practice - Residency Program

This contract renewal is for providing 2.0 FTE to support the ongoing provision of behavioral health services embedded within two clinics for the period of October 1, 2020 through September 30, 2021 and receive \$80,000 for those services.

Revenue Contract Renewal: City of Lansing

This contract renewal is to help cover General Fund costs of Bridges Crisis Unit, for the retroactive period of July 1, 2020 through June 30, 2021. CEI will received \$50,000.

Revenue Contract Renewal: Michigan Department of Health and Humans
Services, Comprehensive Services for Behavioral Health, Hispanic Behavioral
Health Services

This contract renewal is for providing mental health services to the portion of the Hispanic population whom do not have Medicaid within Clinton, Eaton and Ingham Counties for the retroactive period of October 1, 2020 through September 30, 2021 and receive \$35,379 for those services.

Revenue Contract Renewal: McLaren-Lansing

Kay asked what the volume of patients over time has been to McLaren? Shana said the numbers have steadily increased, 55/45 Medicaid/Non-Medicaid or other insurance. CEI has discussed adding staff for more than 12 hours a day, as the need is there, but this hasn't happened thus far. Sara said the real benefit of having CEI staff onsite in the ED is avoiding having the doctor file the CERT immediately, as this generally takes place if CEI staff aren't present to work with the client.

FY 19/20 2nd Quarter Amended Budget AND FY 19/20 2nd Quarter Financial Statements

Stacia said as of March 31st, we have \$25M in cash, \$115,000 in accounts receivable, and \$2.3M in Contracts and Grants Receivable. At this point in time, we had an access of revenues of \$6.6M. Stacia noted that we know now that we are lapsing some Medicaid funds at the end of the fiscal year.

Kay asked about the Autism expenditures, and whether we are encountering more demand than we are prepared for? Stacia said thus far, our revenues are covering our expenditures. Karla said we have a fair number of providers with the ability to take on new clients, and we are meeting demand. Where we struggle is in hiring psychologists, and without enough psychologists, the process of clients accessing services maybe be delayed. Stacia went on to say our costs are somewhat controlled

as far as ABA services, because the State sets the reimbursement rates we can pay our providers.
