Call to Order:

The meeting was called to order by Chairperson Emily Stivers at 5:31 p.m.

Previous Meeting Minutes:

BUSINESS ITEMS:

Expense Contract: Lease Renewal at 5850 Holt Road, Delhi Township

John Peiffer presented this item for a three-year lease renewal. John said in this case, we are leasing to the provider, and they are paying for the utilities.

ACTION:

MOVED by Tim Hanna and SUPPORTED by Dianne Holman that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to renew the lease at 5850 Holt Road from Tariq M. Faridi, M.D. for the retroactive period of June 1, 2020 through May 31, 2022 and pay Two Thousand One Hundred Eight and 00/100 Dollars (\$2108.00) per month (and include a one-time payment of \$492 to bring the lease up to date) to provide a residential home to serve six consumers.

Amended Revenue Contract Renewal: Ingham County, Office of Community Corrections

KC Brown said this item is coming back to Finance Committee because the dollar amount has increased. She said we generally serve about 100 individuals through this contract per year. Sara clarified that we receive referrals through the OCC for this program.

ACTION:

MOVED by Raul Gonzales and SUPPORTED by Dwight Washington that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to enter into a contract renewal with the Ingham County Office of Community Corrections to provide outpatient treatment in the Relapse Prevention and Recovery Program (RP&R) for men and women who have been court ordered upon completion of residential treatment services for the retroactive period of October 1, 2020 through September 30, 2021 and receive \$72,748 for those services.

Expense Contract - Amended Funding: Hope Network

KC Brown said because of the pandemic, some CCBHC funding was not able to be used for its intended purpose. The CCBHC grant states that these funds can be utilized for physician/health services.

ACTION:

MOVED by Tim Hanna and SUPPORTED by Raul Gonzales that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to utilize unspent CCBHC funds to further support the costs of the contracted physician services at The Recovery Center. The amount of CCBHC funding that will be added to the current Hope Network expenditure contract is \$84,000, bring the total contracted amount of this contract to \$148,752. This contract covers the retroactive period of October 1, 2020 through September 30, 2021.

Revenue Contract Renewal: Ingham County Justice Complex Millage for Jail Mental Health Service Expansion

KC said this is the renewal for all Mental Health programming under the Justice Complex millage.

ACTION:

MOVED by Dianne Holman and SUPPORTED by Dwight Washington that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to approve the contract renewal with Ingham County Justice Complex Millage contract totaling \$556,614. The additional funding will support a full time Program Coordinator for the retroactive term of January 1, 2021 through December 31, 2021.

Expense Contract Renewals: Michigan Department of Health and Human Services (MDHHS) Donated Funds Agreements (DFA) - Eligibility Specialists

Stacia Chick said this item is for 1.5 FTE eligibility specialists. At Kay's request, Pam Flory, Reimbursement Supervisor, briefly explained how spenddowns work.

ACTION:

MOVED by Tim Hanna and SUPPORTED by Raul Gonzales that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to enter into an expense contract renewal with Michigan Department of Health and Human Services to purchase Eligibility Specialist services and pay up to \$68,050 for 1.0FTE and \$34,025 for .5FTE Eligibility Specialist positions for the period of October 1, 2021 through September 30, 2022.

Expense Contract Change Order: Metaformers Inc.

Sara Lurie said we have experienced a lot of difficulties with Phase I of the software implementation, the pandemic making those issues worse, and now CFO Stacia Chick will be departing from CEI. The decision has been made to slow down and extend the current implementation period to ensure its success, and Metaformers will remain onboard for the duration of the new implementation period.

MOVED by Dianne Holman and SUPPORTED by Tim Hanna that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to approve a change order with Metaformers, Inc. to extend the implementation period for the Connect (Oracle Cloud) system, from Metaformers, Inc., Reston, VA) and pay up to \$270,895 for the period starting October 1, 2021 through July 31, 2022.

Medicaid Revenue Update

Stacia Chick presented the Medicaid update through April of 2021. She stated CEI is currently over budget by \$12.6M. If this trend continues, we will end up over by \$21M. At this point, the last projections from MSHN showed about \$5.9M of this revenue budgeted for DCW. Sara said right now, no one is being dropped off of Medicaid. Once the State changes this, we will see a big drop-off in Medicaid revenue. Stacia noted fiscal years 2020 and 2021 are quite a bit higher in revenue than any years previous. Sara said we have also not seen expenses yet to compare to the revenue numbers.
