Meeting Minutes

Mid-State Health Network (MSHN) Update:

Board member, Joe Brehler reported that the MSHN Board of Directors met on the first Tuesday in March. The focus of the meeting was the MSHN May Retreat.

CEO REPORT

CEO, Sara Lurie introduced Shana Badgley, AMHS Director; who introduced George Hatter, Charter House Clubhouse Coordinator, sharing that Mr. Hatter is a 29-year employee with CMHA-CEI and has served in various capacities. Mr. Hatter then introduced Jeri Nicole-Wright, and shared that Mrs. Wright recently was awarded an Award from Disability Rights of MI and has worked with CEI and CMHAM as a mental health advocate for many years and also has served on the CMHA-CEI Consumer Advisory Council.

Mrs. Wright expressed her gratitude for the invitation to tonight's CMHA-CEI Board Meeting and invited members of the board as well as community members to join Charter House for their 40th Anniversary celebration scheduled for Wednesday, May 17, 2023 from 12 noon – 4:00 pm. Additionally, Mrs. Wright shared the benefits of having the Charter House Clubhouse in the Lansing community and talked about several of the programs offered including the daily nutritional lunch service provided for their members.

Mr. Hatter shared that Charter House is open daily from 8am – 4pm as well as all holidays and explained that activities take place between 4:00 – 6:00 pm every Wednesday and Thursday, sharing that during COVID Charter House offered a callin line to stay connected with members. Additionally, excitement was expressed when talking about the new Innovation Grant offered by MDHHS which will allow Charter House to support non-Medicaid clients. To date, Charter House has only been able to serve individuals with Medicaid only, reporting that with the addition of the new Peer Support Specialist position, Charter House is now fully staffed.

Another exciting initiative that was shared was the new video photography initiative. Mr. Hatter shared that Charter House members will begin working on this new initiative within the next few weeks as well as explained the tutoring services available to members who choose to go back to school.

Members of the board thanked both George Hatter and Jeri Nicole-Wright for their exemplary work as ambassadors and shining stars, and for presenting at this evening's board meeting, commenting that their presentation was very inspiring!

Board Chair, Dwight Washington inquired about the gender split of the current members. Mr. Hatter advised that Charter House currently has approximately 65 members and are starting to see younger adults; but gender split is about 50/50; with about 15 African Americans; 2 Asians; 1 Hispanic and the other members being Caucasian.

Areas of concern: May need to increase the food program budget. Currently preparing 25 – 30 meals every day; and the price of training has increased significantly.

ACTION: Goal is to get the word out Charter House, and continue to increase membership.

CEO, Sara Lurie thanked both Jeri Nicole-Wright and George Hatter for their presentation today and shared the following CEO Updates:

- Senate Hearing Presentation provided by Sara Lurie regarding Workforce
 Issues and impact on workforce, sharing that our efforts continue to be in the
 area of Recruitment & Retention. However, with so many threats to the
 system and administrative burden this has been very challenging.
- Audit and Reporting Requirements Ms. Lurie advised that CEI participates in a total of 21 audits and submits 77 state require reports, which increase cost in the area of administrative support, and training with all of the code changes to Medicaid Manual and software reconfigurations. Currently we have 3 State Audits we are preparing for and 9 required reports. Staff are overwhelmed with administrative burden; causing burnout and are leaving jobs due to feeling helpless.
