### **ACTION:**

MOVED by Joe Brehler and SUPPORTED by Raul Gonzales that the Finance Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to renew the contract with Peckham, Inc., which establishes mutual understanding about the transfer of the funds, as stated below, for the period of October 1, 2024 through September 30, 2025.

### **CSDD**

A. CMHA-CEI will pay \$38,000.00 to the Michigan Department of Labor and Economic Opportunity – Michigan Rehabilitation Services (MRS) for cash match purposes (known as the Interagency Cash Transfer Agreement (ICTA) - payment) toward the Supported Employment Program (SEP).

- B. Peckham, Inc. will reimburse CMHA-CEI \$19,000 within 30 days of MRS' receipt of payment.
- C. Peckham, Inc. will reimburse CMHA-CEI \$4,750 on a quarterly basis, with payments due by the last day of the quarter (December 31, March 31, June 30, and September 30), for a total reimbursement of \$19,000 during the contract period.
- D. CMHA-CEI will provide a designated staff liaison for SEP to ensure enough job ready referrals (75 for the year) are generated for SEP in order to meet the annual program performance goals.

#### **AMHS**

- A. CMHA-CEI will pay \$63,665 to the Michigan Department of Labor and Economic Opportunity Michigan Rehabilitation Services (MRS) for cash match purposes (known as the Interagency Cash Transfer Agreement (ICTA) payment) toward the Community Work Experience Program (CWEP).
- B. Peckham, Inc. will contribute \$24,720 to CMHA-CEI toward this initial cash match contribution of \$63,665. After CMHA-CEI makes the payment of \$63,665 to MRS, Peckham, Inc. will reimburse CMHA-CEI \$24,720 within 30 days of MRS' receipt of payment.

Worktango would allow the communication and celebration of the Star Service Awards to be instantaneous – it would also broadcast the news to a larger group of folks. Jana noted this would take up far less admin time.

The other process that Worktango would improve is the milestone celebrations. The system would automate these processes. Folks would also be able to opt in to have their birthday announced.

The more urgent item Worktango will be helping with is staff surveys. This will assist in receiving more feedback from staff and will help with retention efforts.

### **ACTION:**

Tim wanted to know how this compares price and quality-wise with the last survey completed? Jana said the only reason we didn't use this consultant last time is because we couldn't get on his schedule. His studies are much more comprehensive. Sara added that we were in an urgent state last time and we went with what was available at the time.

### **SUMMARY OF CONTRACT/PROPOSAL:**

Under this expense contract renewal, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties, (CMHA-CEI) will lease 15,350 square feet of office space located at Building 2, 5303 S Cedar Street Lansing, Michigan 48910 as owned by Ingham County whose address is 121 E. Maple, Mason, MI 48854, for the period of November 15, 2024 through November 14, 2034 and pay ten annual payments each due in the amount of \$64,140.32. The lease term is for ten years.

#### **SUMMARY OF CONTRACT/PROPOSAL:**

Under this renewal contract, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will receive funding from Clinton County for the Integrated Community Youth Outreach Unit (ICYOU) program. This funding will cover the period of October 1, 2024 through September 30, 2025, in the amount of \$81,521.

The revenue and expense of this contract are reflected in CMHA-CEI's FY 2025 budget. The revenue sources that support this contract are funded by Clinton County. This funding covers the associated administrative costs. This contract will not affect CMHA-CEI's fund balance.

## DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/PROPOSAL:

1.) Hire outreach workers to provide skills-based groups to enhance social and emotional wellness of community youth.

The Integrated Community Youth Outreach Unit (ICYOU) is a component of the Families Forward Prevention and Outreach program at CMHA-CEI. ICYOU centers around the idea of a team that can engage youth, families, and communities via creative outreach endeavors such as wellness-oriented training and activities that are coupled with behavioral health components. This outreach would occur in a variety of settings such as schools, community settings, public libraries, and other locations where youth and families spend time. This will provide opportunities to enhance youth growth, development, and skills-mastery in areas such as mental health, coping strategies, self-

care, positive relationships, and other core resiliency-building areas.

The team would meet with youth and parents in a variety of community-based settings to triage issues, refer for immediate service, answer questions regarding youth behavioral health, provide case consultation, assist with resource attainment, and link families with service providers. The additional workforce development this program creates will ensure more immediate access to clinicians in the community and shorter wait times to begin receiving services. Some examples of community-based settings utilized for this programming are the DeWitt Area Recreation Authority's after-school and summer camp programming, Briggs District Library in St. Johns, and Daycare settings in Clinton County. CMHA-CEI is currently providing services at multiple sites in Clinton County.

2.) Identify youth with Severe Emotional Disturbances (SED) and link them with behavioral health services.

While ICYOU groups benefit all youth participants by helping them to develop improved emotional regulation and social skills, youth who have a Severe Emotional Disturbance gain the additional benefit of being identified earlier than they may otherwise have been. ICYOU staff have been trained to recognize the warning signs that a youth may be struggling with SED and how to engage these youths and their families in order to facilitate referrals to behavioral health services. Early referrals to services for these youth can help lower rates of hospitalization, substance use, and juvenile justice involvement and may help improve academic performance, social relationships, and long-term functioning. These referrals may be to CMHA-CEI or may be to community providers, depending upon the severity of symptoms and need.

3.) Provide navigational services to link families with community services and resources.

ICYOU staff are trained to help families link with important community resources and services which families may not be aware of or know how to access. ICYOU staff make many of these referrals across the tri-county area, so Clinton County residents may benefit from referral to these additional resources which they may not be able to otherwise access within Clinton County.

### SUMMARY OF CONTRACT/PROPOSAL:

This revenue contract provides funding for a 1.0 FTE Mental Health Therapist to provide Behavioral Health Consultant (BHC) services in a pediatric clinic located within the tricounty area. These services include providing brief behavioral health treatment, consulting with primary care staff, and offering referral assistance and information on community resources for patients. In addition to providing BHC services, this staff will facilitate "Just in Time" psychiatric consultation for pediatric and OB/GYN practitioners in Clinton, Eaton, and Ingham Counties. This contract is for the period of October 1, 2024 through September 30, 2025.

CMHA-CEI will receive up to \$107,130 for clinical duties performed by the BHC. A separate, but related, agreement supplements up to an additional \$26,782 for the BHC to perform administrative duties related to the grant, such as coordinating regional outreach to eligible providers to engage them in the service and ensure utilization of the program, coordinating outreach to community stakeholders and provider networks, and developing a directory for local and regional resources. CMHA-CEI will receive total compensation of up to \$133,912 for this position.

The revenue and expense of this contract are reflected in CMHA-CEI's FY25 budget. The revenue sources that support this contract are Earned Contracts. The expenses of this contract are reflected in the Families Forward U of M Child Health Care budget.

This contract does cover the administrative costs incurred with the operation of this program. This contract will not affect CMHA-CEI's fund balance.

## DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/PROPOSAL:

This contract allows for 1.0 FTE of Mental Health Therapist/Behavioral Health Consultant (BHC), who will provide services at a pediatric clinic located in the tri-county area. The BHC will serve as an integrated member of the primary care team, and will provide brief individual and/or family therapy. They will also provide consultation to members of the primary care team to ensure behavioral health needs are met. Additionally, the BHC will provide community resource information to patients and referrals for behavioral health services, including CMHA-CEI services. The BHC will also serve as a liaison with the University of Michigan Child Collaborative Care (MC3) Psychiatric Team. In that capacity, the BHC will provide linkage between the Primary Care Provider and an MC3 Psychiatrist. They will also provide first-line, daily phone coverage to enrolled primary care providers. They will assist in triaging and linking identified children, adolescents, and high-risk childbearing women with various psychiatric conditions to phone-based, telemedicine, or face-to-face consultations. They will also be responsible for scheduling consultation appointments between primary care providers and MC3 psychiatrists. Additionally, University of Michigan Psychiatry will be available to provide telepsychiatry when needed.

Under this contract renewal, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will purchase Drop-In/Project Stay services from Justice in Mental Health Organization (JIMHO) at 520 Cherry St., Lansing, MI 48933 that includes peer counseling, emotional support, crisis intervention, and help with daily living challenges for adults with mental illness in a safe and supportive environment and pay \$269,519 for the period of October 1, 2024 through September 30, 2025.

The revenue and expense of this contract are reflected in CMH's FY25 budget. The revenue sources that support this contract are state general fund and Medicaid. The expenses of this contract are reflected in the JIMHO and Project Stay line items of the AMHS budget. This contract does cover the administrative costs incurred with the operation of this program. This contract will not affect CMH-CEI's fund balance.

## <u>DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/</u> <u>PROPOSAL</u>:

The drop-in center services will make concrete contributions to helping people to deal with challenges of daily living, and at the same time offer peer counseling and emotional support. The goal is to provide a substitute support system for people, to take the place of the traditional support systems which the average person enjoys but is absent in the lives of many people living with a mental illness.

The program offers a forum where people discuss relevant issues and work as a focused group to advocate for changes in the mental health system and other public services as needed. Peer-run programs allow discussions and advocacy activities to be carried out without the real or perceived censoring of the presents of mental health professionals.

A drop-in center program provides a critical social support function for people at highrisk for mental health related issues with organized and informal recreational and social activities. Individuals and center staff will assist each other in solving daily living problems (community living, social, recreational, housing, transportation, vocational, etc.)

The program will provide the kinds of daily life assistance which help people make transitions back into the community and help those in the community remain there successfully. The established program will be a support group in the community which is all peer-run. This program will work as an alternative and/or adjunct to traditional community treatment services.

Emphasis will be placed on ensuring individual autonomy, decision making and safety of discussion. The assumption of the organization is that all individuals have something to offer each other and carry that out by helping to run the center and supporting each other. Individuals will develop a sense of usefulness, increases feelings of wellbeing and thus minimize their risk of hospitalization or other more invasive therapies.

#### **SUMMARY OF CONTRACT/PROPOSAL:**

Under this revenue contract renewal with the Michigan Department of Health and Human Services (MDHHS) for Pre-Admission Screenings and Annual Resident Reviews (PASARR), Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will provide evaluations and assessments for individuals who are presented for admission to a nursing facility, or are a current nursing facility resident, located in said service area, as required by the Omnibus Budget Reconciliation Act (OBRA), for the period of October 1, 2024 to September 30, 2025, and receive \$1,409,969 for these services. This budget is flexible in that MDHHS will allow CMHA-CEI to exceed the budget, within reason, and the grant will cover any additional costs.

The revenue of this contract is reflected in CMHA-CEI's FY 2025 budget. The revenue source that supports this contract is the fees paid by MDHHS for prescreens, evaluations, assessments and resident reviews. The expenses of this contract are reflected in the existing Adult Mental Health Services, OBRA budget. This contract does cover the administrative costs incurred with the operation of this program. This contract will not affect CMHA-CEI's fund balance.

## <u>DESCRIPTION OF GOODS OR SERVICES REFERENCED IN</u> <u>CONTRACT/PROPOSAL</u>:

CMHA-CEI will provide evaluations and assessments for all individuals located in the service area who are presented for admission to a nursing facility, regardless of the

location of the admitting facility, and for whom a Level I Pre-Admission Screening procedure (DCH Form 3877) has identified the possible presence of a mental illness and/or an intellectual/developmental disability. This evaluation and assessment will be completed and an appropriate determination made prior to admission of the individual to a nursing facility. This evaluation and assessment will be completed utilizing criteria specified in the Medicaid Provider Manual, Nursing Facility Chapter and the Federal Register/Vol 57, No. 230/Monday, November 30, 1992/Rules and Regulations/Subpart C Pre-Admission Screening and Annual Resident Review of Mentally Ill and Developmental Disabled Individuals. In addition, CMHA-CEI will provide evaluations and assessments for all nursing facility residents in the service area and who have been identified through the PASARR process of having either a mental illness and/or intellectual/developmental disability during the Annual Resident Review process.

#### **STAFF RECOMMENDATION:**

Staff recommends that the Finance Committee of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties approve the following resolution:

The Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to enter into a contract renewal with the Michigan Department of Health and Human Services (MDHHS) to provide Pre-Admission Screenings and Annual Resident Reviews (PASARR) evaluations and assessments for all individuals who are either presented for admission to a nursing facility, or are a current nursing facility resident, located in said service area, as required by the Omnibus Budget Reconciliation Act (OBRA) for the period of October 1, 2024 to September 30, 2025 and receive \$1,409,969 for these services. ### **SUMMARY OF CONTRACT/PROPOSAL:**

Under this contract renewal, Mid-State Health Network will utilize State Opioid Response (SOR) grant funds to authorize CATS to employ a full time case manager, which is a Mental Health Therapist position. SOR grant funding is through MDHHS Office of Recovery Oriented Care and is managed by PIHPs. The funding was originally used to increase access to Medication Assisted Treatment (MAT), but with State permission has become more flexible and can be used not only for Opioid treatment and prevention, but for other substances, such as Methamphetamine.

The contract awards \$142,758 and is to be used for reimbursement of expenses directly related to a Case Manager for the Ingham County Jail and Eaton County Jail MAT programs and Jail Re-entry Services. The agreement is effective from October 1, 2024 through September 30, 2025.

The revenue and expense of this contract is reflected in CMHA-CEI's FY 2025 budget. This contract does cover the administrative costs incurred with the operation of this program. This contract will not adversely affect the CMHA-CEI fund balance.

## DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/ PROPOSAL:

In December, 2020, Mid-State Health Network determined that this position met the SOR guidelines. Case Management positions assist enrolled SUD consumers with support

connections; both in and outside of the jail. This includes but is not limited to; working with the consumer and family to get such items as medications and eyewear; assist with post release connections, including getting back on Medicaid or enrolling in Medicaid; healthcare appointments, continued SUD treatment and finding support groups, housing, etc. Case Managers work closely with Recovery Coaches and Community Healthcare Workers.

#### **STAFF RECOMMENDATION:**

Staff recommend that the Finance Committee of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties approve the following resolution:

The Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to enter into a contract renewal with Mid-State Health Network for the State Opioid Response (SOR) program and receive \$142,758 in order to employ a full time Case Manager position for the Ingham County Jail and Eaton County Jail MAT programs and Jail Reentry Services, which are under the CATS and RECEIPT programs, for the period of October 1, 2024 through September 30, 2025.

This contract includes:

The Recovery Center \$673,433

Fee for Service: (FY 25 rates)

The HOC, CATS, ITRS Outpatient (St. Johns\Lansing), Re-Entry Clinton, and Re-entry Ingham rate sheets are attached.

#### DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/

#### **PROPOSAL:**

CMHA-CEI will provide substance use disorder treatment services for individuals with Medicaid, Healthy Michigan Plan or non-insured (Block Grant/SOR Grant), which generally includes assessment, individual and group therapy, case management and peer recovery coach services. These services are offered in four locations:

### **Fee for Service Programs:**

- 1. **CATS and Intensive Case Management** outpatient treatment located within the Ingham County Jail, which includes case management services for inmates in the county jail.
- 2. **House of Commons** residential treatment for men located in Mason.
- 3. **Re-entry Clinton Eaton Ingham Priority Treatment (RECEIPT)** which is jail reentry services for Clinton and Ingham counties (Peer Recovery Coach involvement).
- 4. **ITRS Outpatient Services** outpatient services in St. John's/Lansing and SUD jail services in Clinton County Jail, which includes both adults and adolescents.

### **Cost Reimbursement Programs:**

5. **The Recovery Center**– medically monitored detoxification services located within the Main CMHA-CEI building.

#### **SUMMARY OF CONTRACT/PROPOSAL:**

The Prepaid Inpatient Health Plan (PIHP) Lakeshore Regional Entity and Kent County Community Mental Health Authority DBA Network180 wish to renew the contract with Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) for Substance Use Disorder (SUD) Long Term Residential Treatment at House of Commons and The Recovery Center. Network180 has limited residential SUD Providers in their region and has been in noncompliance with Medicaid standards regarding individuals requesting treatment who are on a waitlist.

Network180 will pay CMHA-CEI the rates below for the period of October 1, 2024 to September 30, 2025. This is a fee for service contract which will be reviewed annually. CMHA-CEI will enter authorizations into Network180's web based system, NOVA, as we currently do for Mid-State Health Network on their web based system.

The revenue and expense of this contract are reflected in CMHA-CEI's FY 2025 budget in two cost centers. The House of Commons is reflected in cost center 22101 and The Recovery Center in cost center 25102. This contract does cover the administrative costs incurred with the operation of this program. This contract will not adversely affect the FY25 budget fund balance.

#### DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/

#### **PROPOSAL:**

Network180's Access department will refer adult men seeking residential substance use disorder treatment to the House of Commons and The Recovery Center. All current admission eligibility and level of care criteria will be considered for each referral. Individuals who are accepted will be assisted with transportation from Network180 and the length of stay can range from 30 to 90 days, dependent upon clinical need. Services currently provided at the House of Commons/The Recovery Center for MSHN referred consumers will be offered to Network180 consumers, as those services (group, individual, case management) meet Medicaid standards for the program's current level of care (3.5 High Intensity Residential Treatment Program).

#### STAFF RECOMMENDATION:

Staff recommend that the Finance Committee of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties approve the following resolution:

The Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to enter into a revenue contract renewal with Kent County Community Mental Health Authority DBA Network180 to provide Residential Substance Use Disorder Treatment services at the House of Commons and The Recovery Center for the period of October 1, 2024 through September 30, 2025 and be reimbursed per the fee schedule below. Services will be billed through Network180's web based authorization system NOVA.

#### **SUMMARY OF CONTRACT/PROPOSAL:**

This is a contract amendment with the Michigan Department of Corrections (MDOC) entitled Probation Residential Services (PRS). Under this contract, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) House of Commons will provide residential substance use disorder treatment services for felony probationers. Services are to include screening, intake and assessment, group and individual counseling, with a length of stay from 90 – 150 days. CMHA-CEI is at the end of a multi-year contract with MDOC that totals \$825,000 for the period of October 1, 2020 through September 30, 2024. With this contract amendment, or Contract Change Notice, the State of Michigan is exercising the second Option Year, revising and extending the expiration date to September 30, 2025. This amount is a cap and there is no guarantee of revenue under such a fee for service contract. The extension allows CMHA-CEI to utilize remaining funding.

The revenue and expense of this contract will be reflected in the CMHA-CEI's FY 2025 budget. This contract does cover the administrative costs incurred with the operation of this program. This contract will not have a negative effect on the CMHA-CEI fund balance and is only one of multiple contracts needed to support this residential program.

## <u>DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/</u> <u>PROPOSAL</u>:

This is a long time revenue contract through the Michigan Department of Corrections – Probation Residential Services. The House of Commons provides Substance Use Disorder treatment in a residential setting. Individuals served under this contract are felony offenders ordered by a Circuit Court Judge or a Probation Agent to complete treatment in lieu of jail time. This contract covers the State of Michigan, although most referrals are from Clinton, Eaton, Ingham and surrounding counties such as Jackson, Ionia, and Barry. All probationers referred under this contract have a 90-150-day length of stay. The House of Commons admits approximately 150 unique clients under this contract annually. The reimbursement rate for residential services is \$65.00/day.

#### STAFF RECOMMENDATION:

Staff recommend that the Finance Committee of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties approve the following resolution:

The Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to enter into a contract amendment with the Michigan Department of Corrections (MDOC) to provide Probation Residential Services. CMHA-CEI is at the end of a multi-year contract with MDOC that totals \$825,000 for the period of October 1, 2020 through September 30, 2024. This amendment will revise and extend the expiration date to September 30, 2025. This amount is a cap and there is no guarantee of revenue under such a fee for service contract. The extension allows CMHA-CEI to utilize remaining funding.

#### SUMMARY OF CONTRACT/PROPOSAL:

Under this contract renewal, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will provide, for the period of October 1, 2024 through September 30, 2025, the full range of Medicaid and CCBHC behavioral health and developmental disability services (as outlined in the applicable sections of the state's Medicaid manual and CCBCH handbook), the administrative functions required to support the provision of these services, and those managed care functions which have been delegated, by Mid-State Health Network (MSHN), to CMHA-CEI to enrollees within the tri-county community. CMHA-CEI will receive, from MSHN, a capitated payment for each Medicaid enrollee in the tri-county community. This capitated payment reflects the capitated payment received by MSHN for each Medicaid enrollee (which differs by age, gender, and Medicaid program type in which the enrollee is enrolled) less the uniform (equal percentage of the capitation payment) per enrollee administrative costs retained by MSHN to carry out the managed care functions which it retains. For CCBHC services, CMHA-CEI will receive a PPS-1 payment per CCBHC eligible per day of service.

While the actual funding to be received by CMHA-CEI, through this contract is dependent upon the number, age, gender, and Medicaid plan of the persons enrolled in Medicaid during the month for which the payment is intended to cover, the annual revenue based on anticipated 2025 rates and enrollments is estimated to approximate a total of \$185,240,111.

The revenue and expense of this contract are reflected in CMHA-CEI's FY 2025 budget. Medicaid is the only revenue source that supports this contract. The expenses of this contract are reflected in nearly all of the line items in the budgets of nearly all of CMHA-CEI's departments or programs. This contract does cover the administrative costs incurred with the operation of this program. This contract will not affect CMHA-CEI's fund balance if the actual expenses and revenues related to the fulfillment of this contract match those which are projected in the CMHA-CEI's FY 2025 budget.

#### STAFF RECOMMENDATION:

Staff recommend that the Finance Committee of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties approve the following resolution:

The Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to enter into a contract renewal with the Mid-State Health Network to provide, for the period of October 1, 2024 through September 30, 2025, the full range of Medicaid and CCBHC behavioral health and developmental disability services, the administrative functions required to support the provision of these services, and those managed care functions which have been delegated, by MSHN, to CMHA-CEI, within the tri-county community. For the fulfillment of these responsibilities, CMHA-CEI will receive, from MSHN, for this same period, a capitated payment for each Medicaid enrollee in the tri-county community and a PPS-1 rate per CCBHC eligible enrollee per day of service.

#### SUMMARY OF CONTRACT/PROPOSAL:

**1. Period of Agreement:** This agreement shall commence on October 1, 2024 and continue through September 30, 2025.

- **2. Program Budget and Agreement Amount:** Payment to the CMHSP will be paid based on the total funding available for managed mental health supports and services as identified in the annual Legislative Appropriation for community mental health services programs for the period of October 1, 2024 through September 30, 2025. The estimated value is contingent upon and subject to enactment of legislative appropriations and availability of funds, but is anticipated to be \$6,559,230.
- **3. Summary of Contract:** This contract, for Fiscal Year 2025, between the Michigan Department of Health and Human Services (MDHHS) and Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI), in its role as the Community Mental Health Services Program (CMHSP), (sometimes known as the General Fund (GF) contract) uses a methodology for determining GF allocation that entails an operating base with the balance of the allocation based on each CMHSP's non-Medicaid population at or below 200% of the Federal Poverty level. As with past CMHSP contracts between this organization and MDHHS, under this contract, MDHHS will outline the ways in which this CMH will carry out the functions required of a

#### CMHSP.

The revenue and expense of this contract are reflected in CMHA-CEI FY 2025 Steady State budget, using the most recent appropriations process projections. When the actual funding exhibits are distributed by MDHHS, the State General Fund revenue that is projected to come to this organization, as a CMHSP, as a result of this contract, will be adjusted if necessary and reflected in a quarterly budget amendment. The revenues that support this contract are State General Fund dollars. The expenses of this contract will be reflected in all line items of all of the department and program budgets. This contract covers the administrative costs incurred with the operation of this service. This contract will not affect CMHA-CEI fund balance.

**4. Changes from prior contract**: The changes reflected in this contract will be those which have been agreed upon by the negotiation team representatives from the Michigan Department of Community Health (MDCH) and the Contract and Financial Issues Committee (CFI) of the Community Mental Health Association of Michigan (CMHA).

Under this revenue grant renewal, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will accept Congressionally Directed Spending (CDS) grant award funds from the Substance Abuse Mental Health Administration (SAMHSA) to develop and staff a certified Crisis Stabilization Unit (CSU) in the Tri-County area for the budget period of September 30, 2024 through September 29, 2025. Funding in the amount \$2,830,103 will carryforward from FY24 funding in the form of a no cost extension. Payments under this award will be made available through the Health and Human Services (HHS) Payment Management System.

Acceptance of the award including the "Terms and Conditions" is acknowledged by the grantee when funds are drawn down or otherwise obtained from the grant payment system.

Standard and Special Terms and Conditions as well as the award calculation for the FY25 budget period are outlined in the attached Notice of Award. The grant award allows for an adequate indirect rate to cover administrative costs associated with implementing the grant.

The revenue and expense of this contract are reflected in CMHA-CEI's FY 2025 budget. The expenses of this contract are reflected in the CSU-SAMHSA line item of the Adult Mental Health Services budget. This contract does cover the administrative costs incurred

with the operation of this program. This contract will not affect CMHA-CEI's fund balance.

## DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/PROPOSAL:

The primary goal of the project is to develop and staff a certified Crisis Stabilization Unit in the Tri-County area that will reduce the impact of substance use and mental illness in the community by serving persons experiencing an acute behavioral health crisis, which requires secured treatment to safely manage.

CMHA-CEI will work closely with external specialists, who will provide subject matter expertise in CSU design, implementation, and certification. The Grant also includes start-up funds to hire the additional staff needed for the Crisis Stabilization Unit.
