Board Chair, Maxine Thome thanked Ms. Pelton for the Human Resources presentation this evening, noting the impressive accomplishments, then called for questions from the board members.

Ms. Pelton fielded the following questions from the board:

Are these paid internship programs?

Answer: No, CMHA-CEI does not offer paid internships. However, there is a stipend available through the State of Michigan that may be available.

• Does CMHA-CEI, Human Resources Department work with MIWorks to post open positions?

Answer: Yes, CMHA-CEI post relief positions through MIWorks and also attend several career fairs throughout the year for entry-level positions.

How hard is it to market the Mid-Michigan area for potential relocation?

Answer: Not hard at all, I merely need to say "Michigan State University", and that gets their attention!

Have you considered offering collaborative relationship?

Answer: Bob Sheehan, CMHAM Chief Executive Officer shared his previous experience with collaborative relationship and stated that this is becoming a thing of the past and something probably not worth pursuing.

• We have a fairly sizeable immigrant/Hispanic population. Is Diversity considered when selecting intern candidates and if not, this may be something to consider down the line.

Answer: CMHA-CEI, HR does not exclude any applicants. Our review is based on who is getting in to social worker schools. We also have a pipeline into the high schools.

Do we look at things such as whether the participants are bilingual?

Answer: No, speaking more than one language is not currently a factor that is considered for internship.

• What is the biggest challenge in recruitment right now?

Answer: Continuing to attract master and doctorate level candidates.

• Are there placement and career opportunities available following internship?

Answer: Yes, some folks come to work for CMHA-CEI after Internship. Additionally, Chief Human Resources Officer, Jana Baylis explained that Ms. Pelton currently goes into the programs and presents opportunities prior to completion of internship programs making interns aware of employment opportunities within the agency sharing CMHA-CEI's generous benefit and salary information.

What is the greatest need?

Answer: Bachelor level clinicians, therapists and counselor positions.

Joe has represented us on the Mid State Health Network (MSHN) Board of Directors and recently has helped see this organization through many successes as we embraced becoming a CCBHC in addition to participating in planning and ground breaking when we built the large addition to this building and now has supported the development of the new Crisis Care Center. In recent years, Joe has seen us through challenges (including a Global Pandemic), labor shortages, and large scale community trauma.

On a personal note, while I have had the opportunity to see the impact of Joe's dedication to improving access to behavioral health care up close over the past 9 years, I also had the opportunity prior to being here through my former role at Eaton RESA for 13 years to see and experience the incredible wide scope of work and support you champion in Eaton county to assure that health, safety, human services, and educational resources are at the forefront of county decision making. Many times over the years, I have had the opportunity to see Commissioner Brehler passionately make a case to fellow commissioners that sways people into making the "better decision" to the benefit those in the community who don't have a voice. I feel so fortunate to have had the opportunity for your guidance and support and I will miss your wise counsel in all matters.

Thank you for your unwavering dedication and remarkable contributions over the past two decades. We will miss you greatly around this table and on behalf of the Board, staff and those we serve, we thank you for your dedication and commitment and we wish you well always! You will always be an important part of this organization's legacy.

CEO Lurie, then turned it over to Bob Sheehan, former Executive Director and CEO of Community Mental Health Association who presented the CMHSP Board Member Longevity Award for 20+ years of dedicated and shared that Joe is a champion for the marginalize with his number one priority being healthcare with a local focus for impact, expressing that when Joe shows up, things happen as he brings gravity and fiscal responsibility. Payor shall prior authorize up to two days Enhanced Staffing Inpatient Psychiatric Services for Consumers in this situation on a case by case basis. Criteria for Enhanced Staff Inpatient Psychiatric Services are as follows:
- 1. The Consumer must meet all of the Inpatient Admission Certification Criteria listed above (Diagnosis, Severity of Illness, and Intensity of Service).
- 2. The Consumer is failing at least restrictive placement despite active treatment, with no expectation of improvement in a timely manner, combined with risk factors to Customers or Hospital such as: Swallowing behavior on unit, aggression towards others, and/or extreme property destruction at such a level that Consumer requires constant attention from staff in order to prevent self-harm, harm others, or extreme property destruction.
- **The Administrative Day Rate is to be used when a consumer no longer meets medical necessity for acute hospital care but circumstance make discharge to sub-acute or a post-acute setting problematic. The respective Neuropsychiatric Hospitals, LLC hospital facility will work the responsible CMHC on discharge planning to ensure a safe and timely discharge of the patient.
