Frederick C. Blow, Ph.D. is Professor and Director of the Mental Health Service Outcomes and Translation Section in the Department of Psychiatry at the University of Michigan Medical School and Director to the National Serious Mental Illness Treatment Resource and Evaluation Center (SMITREC) for the Department of Governmental Affairs, Ann Arbor, MI. Additionally, he is the first National Huss/Hazelden Endowed Research Chair on Substance Abuse in Older Adults at the Butler Center for Research at the Hazelden Foundation located in Center City, Minnesota. He is a national expert in mental health and substance abuse service research and policy, with the focus on evidence- based practices.

**SUMMARY:**

The number of older adults with mental illness (MI) and/or substance abuse (SA) problems are often seen in the primary care setting. The mental illness and substance abuse problems, when present, may go undetected or masked by other co-morbid disorders. Learn how to screen for MI/SA disorders, how to implement MI/SA prevention and early intervention strategies for older adults.

**OBJECTIVES:**

1. Understand demographic trends and important issues associated with preventing mental health and substance abuse problems in older adults including demographics, extent of the problem, alcohol abuse and co-morbid mental health problems, alcohol use in older adults, lifetime patterns of drinking.
2. Learn screening and brief motivational interventions for alcohol misuse among older adults.
3. Learn the principles, core components and the implementation science and processes needed to successfully implement substance abuse and mental health prevention and early-intervention evidence-based practices for older adults.

Dr. John Gardin II, Ph.D, is a licensed Clinical Psychologist in Oregon and California. Dr. Gardin sits on the National Steering Committee for the SAMHSA/HRSA Center for Integrated Health Care Solutions and is the National Chair for over 240 clinical treatment programs that participate in NIDA’s Clinical Trial Network. He is a Clinical Assistant Professor at Oregon Health Sciences University Medical School, a Credentialed Health Service Psychologist with the National Register and a Fellow of the American College of Advanced Practice Psychologists. Dr. Gardin is the Chief Clinical Officer for ADAPT, a non-profit, licensed Substance Abuse Treatment agency serving the residents of three counties in Southern Oregon and ADAPT’s SouthRiver Medical Clinic, a FQHC.

**SUMMARY:**

Patients in primary care often present with substance use issues which complicate medical care and consume inordinate amounts of staff time. In this session attendees will become familiar with SBIRT (Screening, brief intervention, referral and treatment) and DRAMA, a 5 step algorithm designed to assist medical staff in facilitating appropriate engagement in the change process.

**OBJECTIVES:**

1. Know the reasons for substance misuse screening, brief intervention, referral and treatment (SBIRT) in primary care.
2. Be able to identify the key components of SBIRT.
3. Know key organizational issues, key clinical issues, and key financial issues to successful SBIRT implementation.
4. Be able to identify the 5-step algorithm DRAMA.
