<u>Update of Evaluation of Programs (who could be moved back to Jolly for cost Effectiveness, etc) – John Peiffer</u>

John Peiffer conducted a study and the results were that *Wardcliff, Charter House, ACT* might be possible options to consider as far as what programs could be moved back into the Jolly Road facility after the new expansion.

The idea would be to bring a couple of programs back to Jolly Road to help with the cost of the new expansion.

## Update on the RFP Process for Architectural Services - John Peiffer

Six architectural firms have been identified and will be sent a RFP. The pricing will be broke down from design of the project, construction, completion and close out of the project. Three phases priced separately. The RFP deadline to submit price proposals is July 7<sup>th</sup>.

## Financing Update - Stacia Chick

Stacia Chick met with Chase Bank staff and learned the payoff could be bundled but it depends on what the value of the loan will be. The bank will do a pre and post appraisal. CMHA-CEI has the option to purchase but cannot be exercised until July of 2018. CMHA-CEI will go back to the building authority to see if we can renegotiate the language to purchase the building for a \$1.00. CMHA-CEI is paying 5% interest on the lease on the Jolly Rd building. It was not a fixed interest rate. Construction loan is usually interest only and it is for the life of how long it takes to building the building. Interest rate to borrow varies. Currently there is 480,000 in our budget, CMHA-CEI could sustain at loan at 4% for a loan of 7 million.

Bob Sheehan summarized the next steps. The RFP will be sent out. When bids are returned, they will be brought back to the Building and Sites Committee. Stacia Chick and Bob Sheehan will meet with Ingham County Building Authority.
