#### Call to Order

#### **Public Comment on Agenda Items:**

**Public comment included:** 

Kerby Rials, a friend of Stephen Ley and his parents expressed concern regarding the respite benefit changes and commented that he did not feel as if these changes are in the spirit of mental health. Mr. Kirby encouraged the board to reconsider their decision.

Nancy Beach, Valley Residential Services, Inc. distributed a prepared statement which expressed her displeasure with both the RFQ and guardian processes not being transparent. In addition, Ms. Beech also noted that guardians were not part of the provider selection for the home.

On behalf of the guardians at the Turner Home, Jenny Bhaskaran also expressed concern regarding the RFQ process. Ms. Bhaskaran also commented that they too are very displeased with the fact that guardians were not part of the process of selecting providers for the home and reitterated the sentiments of Nancy Beach from Valley Residential Services, Inc., regarding the process not being transparent.

Patricia McKenna-Ley, introduced her son, Steffan, who is 29 years old.

Ms. Ley continues to advocate for a small number of families whose adult children will be losing respite services and their preferred respite provider effective October 1. Ms. Ley stated that as we listen to the respite plan presentation for the first time tonight, she asked that the board consider the following thoughts and questions on behalf of the adult children that CMHA-CEI serves:

- 1. Will the respite plan that is being presented tonight be open to public comment?
- 2. Is CMH willing to seek input about the respite plan from those parents whose adult children will be negatively impacted by its implementation and adjust the plan to ensure the best outcome is achieved for all adults and children served?
- 3. How did CMH arrive at the October 1 effective date for the reduction or elimination of existing respite services for adults?
- 4. Can this date be pushed back to allow for parent input?
- 5. Under what authority is CMH working from to reduce and cap all adult respite services down to \$1,200 or 120 hours per year?
- 6. Under what authority is CMH working from to categorize any respite services needed over 120 hours per year to now be an "exception?"
- 7. Under what authority is CMH working from to eliminate our adult children's ability to continue attending Horizon Behavioral Solutions respite home effective October 1?

Patrick Ley stated that this is his fifth time pleading to the board members and offering public comment regarding the respite benefits for his son Steffan. Mr. Ley expressed concern regarding the fact that he is being told that effective October 1 CMHA-CEI will no longer pay for respite services at Horizon for adults due to the fact that Horizon is not licensed to provide respite services to adults, only children. Mr. Ley inquired about interim services at Horizon during the

period Horizon is working with the state licensing office. With frustration Mr. Ley indicated that the time for talking has now expired.

Mr. Clark spoke on behalf of his family (Lisa, his wife and Stacy, his daughter). He starting out by stating "I don't even know why I'm here!" I'm dad, I am the provider for the family. My wife is the nurturer of our 28 year old non-verbal autistic daughter. The services that have been provided to our family have really strengthened our family. The changes that are being proposed will be very disruptive to every family here and many of those who are not here this evening. Respite services should be enhanced not reduced. "It is really hard to find qualified staff to care for our children because of their developmental disabilities."

Teri Geiesenbach commented that she needs to feel caring from this board and she is not feeling much flexibility.

Laurie Coruin announced that she came this evening to support her brother in law, sister, and nephew (Steffan). Ms. Coruin started out by saying that "you don't have a clue what it is like to have a child that has such special needs. His parents do not get time off, they need respite care! "To take this benefit away from them will be devastating! At that point Ms. Coruin, asked that the board members please look at her and continued by stating "you don't have a clue what this is going to do to the families." "He deserves good care!" Why are you taking this benefit away from them? All these families deserve a break and to have a weekend that is normal. Pleas, I am begging you to think about this before you take things away.

Julie Shay stated that back in 1989, Pat Kelley had a dream and worked really hard to get this program implemented. Ms. Shay stated that she knows this first hand because at that time her husband, Jerry utilized the services. Jerry died in 2009 and I felt blessed to have been able to work with CEI to provide the needed care. This program was a God send for us! CMH never hid anything back then. Steffan is non-verbal, he cannot do anything on his own. It is a relief to know your loved one is in a safe environment and receiving the care they need when you personally are not there to provide the care.

All of these people just want somebody to care as much as they care about their children. Please, I have been around since the program's inception and know that this is not what it was intended to be.

#### Mid State Health Network Update

Joe Brehler reported that MSHN Board met on Tuesday, September 11. The annual allocation was not passed due to concerns expressed regarding fiscal continuity. Additionally there was a sizable amount of opposition on the board regarding the MDOC contract. This item has been tabled pending a request for an additional year extension. The next meeting is scheduled for November.

#### **CEO Report**

Sara Lurie clarified that there are no plan being proposed this evening or subject to voting. There are no changes to respite services. However, there is a change to CEI's understanding of the services.

Ms. Lurie then introduced Stacia Chick, Chief Financial Officer, who introduced Nicholas Carey, Financial Operations Manager.

### **Funding Source**

Mr. Carey presented Funding Sources. Highlights from the presentation included the following:

• Federal Funds

- State of Michigan
- Local
- Medicaid
- Other Contracts
- Charges for Service
- Investment Income

There was an inquiry as to whether ISF comes back as local funds. Per Stacia Chick, CFO, ISF does come back as local funds.

### **CSDD** Respite

Karla Block, CSDD Director introduced Marie Carrell, Life Consultation Supervisor and Amy Wortley, Life Consultation Coordinator.

Ms. Carrell stated that as you have heard this evening, respite is a service that is of value to families. However, there are several misconceptions. We are here this evening to clarify some of those things and make a clear distinction between adults and children. Highlights form the presentation included the following:

#### **CSDD Service Numbers:**

- 1170 Total Adults Life Consultation
- 318 Total Children Family Support
- 536 Total Adults & Children in Respite Service

Effective October 1, we are exploring additional ways (increased options) o support folks:

- CSDD Respite Providers
- Respite in Group Homes
- Respite in Child Caring Institution
- Respite Home for Children CCI
- Contract Respite Providers
- Self-D Option
- Base Allotment \$1,200 year (higher clinical needs are addressed through the Person Centered Planning Assessment.)

Ms. Carrell explained that as Ms. Lurie indicated earlier, there are no changes to respite services. However, there is a new understanding on behalf of CMHA-CEI of the law. Our understanding leading up until now was incorrect and encouraged families to speak with their care managers regarding the above options.

Discussion ensued regarding whether or not Horizon Behavioral Solutions will be able to continue respite care for adults after October 1 or would they have to consider opening a separate facility for adults. Ms. Carrell responded that due to licensing law and regulations effective October 1, Horizon Behavioral Solutions will provide respite services for children as a Child Caring Institute (CCI.) If adults are interested in continuing to receive respite services the

provider can remain attached to families and care can be provided in the consumers "own home" Ms. Carrell encouraged families to reach out to Horizon Behavioral Solutions as this is a licensing issue and not driven by something CMHA-CEI can control.

Kay Randolph-Back inquired about what families are supposed to do during the transition period to maintain continuity and consistency during the time Horizon Behavioral Solutions is working with the state licensing office and the potential of some economic loss.

The board inquired as to how many people fall within this category? Amy Wortley estimated about fifteen families.

ACTION: Karla Block and the CSDD staff were not exactly sure how many people fall within this category, however will compile a list of the number of affected consumers and the frequency and will report back to the board.

ACTION: Dianne Holman suggested making a notation on our website that reassures consumers, guardians, etc., that respite is not being cut. However, we have a new licensing understanding.
