Call to Order:

The meeting was called to order by Committee Member Paul Palmer at 5:34 p.m.

Previous Meeting Minutes:

BUSINESS ITEMS:

New Revenue Contract: MDHHS Block Grant – Crisis Intervention Training Coordinator/Justice-Involved Outpatient Therapist

KC Brown presented this item for block grant money to add 1 FTE Mental Health Therapist to be the CIT Coordinator and perform therapist duties in ITRS outpatient services.

Tim asked if any of the hires through any of the block grants presented here tonight have already been hired, and what happens to these positions if the block grant ends? Sara said these positions can't be posted until the items go through the CEI Board approval and State approval processes. If they are hired, Sara is hoping the

positions will be posted by the end of May. Sara said many grants have the ability to renew each fiscal year, so we are hoping that is the case for these positions, but we will also search for new funding sources in the meantime. She went on to say there are quarterly report outs on the work plan and the grant's finances to MDHHS. Tim asked, "What happens if the position isn't filled?" Sara said the dollars don't get spent, in that case, and so the block grant dollars cannot be carried over to the next fiscal year.

ACTION:

MOVED by Al Platt and SUPPORTED by Tim Hanna that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to utilize MDHHS Mental Health Block Grant awarded funding in the amount of \$36,116 for a 1.0 FTE Mental Health Therapist. The MDHHS contract begins June 1, 2021 through September 30, 2021. Funding will be available FY22 and FY23.

Gwenda Summers said Families Forward also applied for Mental Health Block Grant dollars. These funds are going to be used to have staff to link families in the community to our services. Our staff will also provide wellness activities in the community. There will be a team of people in these locations providing outreach and engagement.

Of note, subsequent years will be FY22, October 1, 2021 through September 30, 2022, in the amount of \$240,000 and FY23, October 1, 2022 through March 14, 2023, in the amount of \$120,000.

New Revenue Contract: MDHHS Block Grant: Law Enforcement Co-Responder Project

Shana Badgley presented three items funded with Mental Health Block Grant dollars. This first item would be in conjunction with Lansing Police Department and a social worker. We have a similar project with Meridian, and are looking to expand the co-responder models.

MOVED by Al Platt and SUPPORTED by Tim Hanna that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to utilize MDHHS Mental Health Block Grant awarded funding for FY21, June 1, 2021 through September 30, 2021 in the amount of \$158,000. Of note, subsequent years will be FY22, October 1, 2021through September 30, 2022 in the amount of \$240,000 and FY23 October 1, 2022 through March 14, 2023 in the amount of \$127,000.

Shana Badgley presented this next item for two FTE Peer Recovery Coaches, two FTE Peer Support Specialists, and one FTE Client Services Specialist in order to assist Case Management Services and the Assessment Referral Team, which are seeing an increase in substance use disorders.

MOVED by Al Platt and SUPPORTED by Tim Hanna that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to utilize MDHHS Mental Health Block Grant awarded funding for FY21, June 1, 2021 through September 30, 2021 in the amount of \$75,000. Of note, subsequent years will be FY22, October 1, 2021 through September 30, 2022 in the amount of \$236,779 and FY23, October 1, 2022 through March 14, 2023 in the amount of \$115,446.

Of note, subsequent years will be FY22, October 1, 2021through September 30, 2022 in the amount of \$260,000 and FY23 October 1, 2022 through March 14, 2023 in the amount of \$135,000.
