Meeting Minutes

Mid-State Health Network (MSHN) Update:

Joe Brehler provided an update from the most recent meeting. MSHN believes they will now be entering a surplus situation. Previously, MSHN thought they would be in deficit. Joe noted that the next meeting is sometime in July.

Joe saw a copy of MSHN's resolution regarding Conflict Free Assessment and Planning. There was feedback from the meeting attendees that they resolution was watered down. Several CMHs told MSHN they did not want to move forward with the resolution at all. The Director of MSHN told the group that he wanted to call a meeting with the State and indicated that he would never advise us to oppose the State and that we should acquiesce

with Conflict Free Assessment and Planning. There have now been several State proposals that would greatly impact the public behavioral health system in the state and could be the beginning of the end of the system. Joe said it seems that, at the end of the day, when push comes to shove, the Director of MSHN will be siding with the State.

Board Member Paula Yense said she sent letters to her representatives and to the Governor opposing Conflict Free Assessment and Planning. The Governor's office told Paula this is not a State issue; it is a federal issue. Paula went ahead and sent letters to the contacts provider to her by the Governor's office.

Maxine Thome reentered the meeting at 6:15

Joe said there has been some discussion of a FOIA request to figure out what's going on at the State. We created PIHPs to protect the CMHs.

Board Member Paul Palmer was also at the last MSHN meeting. He supports what Joe is saying.

CEO REPORT

CEO, Sara Lurie provided verbal updates on the following item from her written report:

Conflict Free Assessment and Planning & Next Steps

Sara wanted to let the Board know we have received no details from the State, and until there is more information, there is no way to evaluate or plan for this at CEI. We seem to be hearing from different parts of MDHHS that are trying to protect their areas. We know that people enrolled in and receiving services through CCBHC will be exempt from Conflict Free Assessment and Planning. So, too will the folks coming through crisis stabilization and the crisis unit. Sara said conflict free assessment and planning is a terrible idea for the system all around. She said she will be asking the counties if they would like to prepare a resolution as well. Sara said we do have approved waivers through 2027. Some things we continue to do to show opposition is Action Alerts - one went out last week, and Sara will send another out next week. There were approximately 900 communications that went out to legislators. Sara said Paula's response from the Governor's office is very discouraging. She went on to say, at some point, she will be asking Board members to go with her to meet with State senators and reps. Sara thinks it's probably time to sit down and talk with them. She said she wishes she could give the Board a clear vision of what the impact of Conflict Free Assessment and Planning, but we have no idea what that would look like yet.

CCBHC

The State is expanding CCBHC sites. This is a good thing! CEI has been able to do more under CCBHC. One issue is that we are seeing folks dropping off of Medicaid while we continue to serve them under CCBHC, with a portion of the State budget going to CCBHC. Even though many more sites have been added, that pot of general fund money has not grown from \$500k. This means CEI will be receiving less of the general fund.

NASW MI Award

Sara pointed out the Agency of the Year award displayed in the Atrium! We have received the official award, and it is beautiful. Sara shared CEI's official award video with the Board.

Maxine Thome left the meeting at 6:38 pm. Joe Brehler assumed chairperson duties in Ms. Thome's absence.

Sara said we are hoping to have a reception in August for the nine members of the staff cohort to come and meet the Board and celebrate this achievement.

Mental Health Awareness Day Proclaimed in Lansing

Mayor Andy Schor proclaimed May 13th as Mental Health Awareness Day in the city of Lansing! Sara received a plaque with the proclamation and shared it with the group.

Public Comment

Diane Shorter spoke first. Ms. Shorter has been in the CMH community for 35 years. She spoke about her two children briefly. Diane is originally from Virginia – she has since made Michigan her home. The good news is she just bought a house! The bad news is her car was stolen.

Ms. Shorter is dealing with some problems with Dr. Stanley. Dianne said she is waiting for a signed letter from Dr. Stanley saying she can drive on her medications that she can give to the Secretary of State. She has been waiting for a long time for this letter. Diane would like to know why Dr. Stanley can't and won't fill out the form and why she was put on so much medication. She has exhausted all avenues and would like to know what the Board suggests. Diane would like to help her family but she cannot do this without a car.

Daniel Arnold then spoke to the Board. He presented a piece of his own history to the Board regarding his struggles with mental health. Daniel spoke highly of his last hospital visit in March of 2019 and what has transpired in his life since then. Daniel shared positive experiences with Dr. Arnold at CEI. He continues to share his story with folks around the community and beyond. Daniel says he needs the services of CMH. He is grateful that Dr.

Arnold stayed with him during his hardest struggles.
