My name is: Daniel K. Arnold, and I am the new Consumer Advisory Council Representative. I am elated to be here! Today, I will answer the following questions:

- 1. Who am I and what do I do in the community?
- 2. What perspective do I come from historically?
- 3. Why do I want to be the Consumer Advisory Council Representative to the Board?
- 4. What modern issues do I care about relevant to CMHA-CEI?

Please allow me to elaborate on each of the above questions:

# Question #1 - Who am I and what do I do in the community?

The Lord has opened the door for me to do what I love and serve in the following capacities:

# Tri-County CIT Consumer Advocate Board Member

CIT stands for Crisis Intervention Team. They oversee a training for first-responders (predominantly law enforcement) to de-escalate those with mental illness to mental health care instead of incarceration. The whole steering committee is delightful. I was able to sit in on the last Tri-County CIT Training in November 2023 and was sent to the International CIT Conference in Indianapolis.

My Lived Experience with Schizoaffective/Bipolar/ADHD is valued. I am a key player and love being around these professionals.

# **<u>CIT International Public Policy Advisory Council</u>**

On Zoom, I enter a room full of people who care about the International CIT Model. I am just beginning to get involved. I love being exposed to a global perspective.

# Justice in Mental Health Organization Board of Directors

JIMHO Drop-In I have been a part of for at least 15 years. I've had difficult encounters there in the past around the time of my past hospitalizations, but now I'm entrusted with serving on the board. I am eager to be a part of their future and voice.

JIMHO provides mental health consumers with a place to dwell with other consumers safely in a peer run drop-in center. Some consumers are homeless and have the opportunity to relax with coffee, television, group activities, friendship, and social services. I'm very proud of the current direction of the team and the niche they fill to help those in need.

# Charter House Clubhouse Advisory Board

Charter House Clubhouse provides a work-ordered day preparing consumers to better themselves. There is Neuro-Diversity, all walks of life, with staff support. Everyone, including staff, identified as members. Some prepare for actual work. I submit newsletter articles, write books, and do online training.

Charter House Clubhouse has amazing gourmet food cooked by the team. It's so yummy for a dollar. Wednesday I had a Reuben sandwich for only 50 cents. There is a lot of open space in here. Many computers. Some with sound. I love how everyone treats me and welcomes my unique talents. I really feel I belong and invite people to come visit.

Charter House Clubhouse is on the lookout for more Advisory Board Members such as yourselves. We meet the third Friday of the Month at 12 noon. I can't wait to see you there!

## **CMHA-CEI Consumer Advisory Council**

The CMH Consumer Advisory Council I joined in April of this year for a two year term. The consumers, the Board Member Raul Gonzales, Becki West, the CEO Sara Lurie — everyone, are all very kind people. I am overwhelmed by the level of humility and skill in meetings. It's is actually very fascinating to participate and see everyone's enthusiasm.

## Mid-Michigan Police Academy Behavioral Health Emergency Partnership Presenter

The opportunity to present to police recruits in training touches deeply into my soul. I have presented twice on my mental illness diagnosis descriptions. I go on to pass out about 20 pictures of my life. I explain three aspects of sacrifice and my mental health perspective in 13 scenarios from my first interaction with police in my criminal actions at the MSU Riots to where I am today as Lansing's #1 Fan of Local, State, Federal Security/Police. I appreciate their service and cheer them on to their honorable profession. At the Academy I laugh, I cry, I'm overjoyed!

The above presentation is my 19th published book and it is entitled : "Journey To CIT."

# <u>Crossroads Church Children's Ministry Volunteer, Welcome Team Volunteer,</u> <u>Former Safety Volunteer</u>

Crossroads Church Attendance has coincided with my successful recent mental health track record. They are welcoming and spur me on to be a loving community member!

# **Community Mental Health Association of Michigan Conference Presenter**

I have presented at CMHA Michigan Conferences twice and am slated to present again February 2025. I'm grateful for being entrusted with another opportunity. Periodically, I meet with the CEO of CMHA Michigan Bob Sheehan, Former CEO of CMHA-CEI. I love to prepare and the coming conference I cannot wait for!

Unofficially I spend time speaking at Lansing City Council, Lansing Board of Police Commissioners, and visiting 8 government properties a day to speak to Local, State, Federal Security/Police in Capital City Downtown Lansing, Michigan, USA.

## Question 2 – What perspective do I come from historically?

To summarize, I have been diagnosed ADHD, Bipolar, Schizoaffective with many bouts of non-compliance to take medication. I've gone from combatting the system to realizing the "Lowest Therapeutic Dose" of medication I am now on for over five years has saved my life!

I believe "If mental health workers can learn to be their clients' #1 cheerleaders, they will be drawn to Community Mental Health, where C.M.H. = See My Healing!" (There is much more I want to share. I had to cut down this historical presentation considerably.)

# Question #3 – Why do I want to be the Consumer Advisory Council Representative to You the CMHA-CEI Board of Directors?

This is a change of pace for me. I've always approached public speaking with my own independent voice. For the first time, I am called to represent the voice of mental health consumer leaders. This is a new project I am called to.

I will learn on the fly. I know I will learn to represent a diversity of issues and people. I desire the increased opportunity to appear before you the board and other speaking engagements.

I am translating here from presenting just my own perspective to making an effort to listen and represent others. My ADHD brain finds it difficult to wrap itself around the broad scope.

So often I wander around government properties and my church building learning bits and pieces of the big picture. This assignment seems daunting at first, but I know I can step into it. I will be given bullets written out to help me present. I hope I can get to know some of you more closely as board members as I participate regularly. I do not just want to present a speech, I desire your feedback—to interact to truly make a difference in the happenings of CMHA-CEI representing the council.

You are all a part of my adventure into this new world. It's exciting to learn how much those who make up CMH really care.

#### Question #4 - What modern issues do I care about relevant to CMHA-CEI?

With past service on the Recipient Rights CAC and Mid-State Health Network RCAC, I have developed a passion for giving the opportunity for consumers to give feedback on their care.

At one point, I filed a grievance and had my psychiatrist switched. For me, this autonomy was one of my best decisions. I always want to be a voice into the quality of services that involves the consumer voice across the board of all the diverse CMH programs.

On another side, with my communication with law enforcement I care about their approach to mental health consumers. I will always encourage a deeper partnership to get people the help they need and reduce stigma.

#### Other CEO Updates included:

## Introduction of Leslie Bartlett, Acting CSDD Director

Leslie Bartlett is the Clinical Services Supervisor in CSDD, and has stepped as the Acting Directors since Karla Block's retirement as we continue the hiring process.

With regards to an update regarding the hiring process, two rounds of interviews have been conducted over the past two weeks, and I am happy to announce that Drew Kersjes, Residential Supervisor in CSDD has accepted the position and will be transitioning with a start date of Monday, November 11, 2024. We will do a more formal introduction of Drew at the November Board Meeting. In the meantime, Leslie has graciously agreed to continue in the Acting Director role until Monday, November 11, 2024. Thank you Leslie!

#### MichiCANS and EVV Updates

CEO, Lurie shared that the launch for both initiatives, which are State and Federal requirements for home health services as well as other agencies, has occurred! Reporting that several refinements are needed and both initiatives continue to heavily impact the Information Technology, Adult Mental Health Services, Clinical Services for Developmentally Disabled and Families Forward programs, although planning for both initiatives has been in place for over a year now.

EVV requires staff to carry tablets for home visits and also requires that families verify upon arrival of staff, the beginning and upon departure, the end service times as this is how billing is triggered, noting that both are huge projects that all started around the same time.

#### **Crisis Stabilization Unit Progress**

With excitement, CEO, Lurie announced pre-construction demolition is scheduled to begin this month, and that the public notices end October 23 with meetings continuing to work on legal documentation in hopes to get final signatures which would allow us to move forward with bonding.

At any rate CEI continues to move forward with the planning of the wall breaking ceremony which has been scheduled as follows:

Date: Monday, November 25, 2024 Time: 1:00 – 3:00 pm Location: 2901 Stabler, Lansing, MI 48910 CEO, Lurie reporting that to date, attendance of US Senator Debbie Stabenow has been confirmed. Additionally, invitations to the upcoming wall breaking ceremony have been extending to CMHA-CEI Board of Directors, Community Advisory Council (CAC), as well as to Eaton, Ingham and Clinton Counties partners.

\*On rare occasions, consumers may be admitted to the hospital who require substantially higher amounts of one to one staffing than is typical, due to highly aggressive or self-injurious behavior. Payor shall prior authorize up to two days Enhanced Staffing Inpatient Psychiatric Services for Consumers in this situation on a case by case basis. Criteria for Enhanced Staff Inpatient Psychiatric Services are as follows:

1. The Consumer must meet all of the Inpatient Admission Certification Criteria listed above (Diagnosis, Severity of Illness, and Intensity of Service).

2. The Consumer is failing at least restrictive placement despite active treatment, with no expectation of improvement in a timely manner, combined with risk factors to Customers or Hospital such as: Swallowing behavior on unit, aggression towards others, and/or extreme property destruction at such a level that Consumer requires constant attention from staff in order to prevent self-harm, harm others, or extreme property destruction.

For the fulfillment of these responsibilities, CMHA-CEI will receive, from MSHN, for this same period, a capitated payment for each Medicaid enrollee in the tri-county community and a PPS-1 rate per CCBHC eligible enrollee per day of service. # **Executive Committee Meeting**

Board Vice Chair, Joe Brehler reported that the Executive Committee met on Monday, October 14, 2024 at the Crowne Plaza Lansing Hotel for the CEO Performance Evaluation, reporting that out of 12 board members, we received 10 completed evaluations; which is 80%. CEO Lurie, received an exemplary performance review for the second consecutive year, with one less than satisfactory mark in the area of budgeting; due to the fragmented process, making it difficult to get a sense of the picture (noting the inconsistency of the State funding being a primary factor).

One area of concern that was brought forward in the area of diversity as an area for improvement for the coming year was the matter of under-represented groups. Discussion ensued. Sara shared that the new DEIJ Administrator position was recently filled and this is one of the areas that will be focused on as we look to revamping the mentorship program with a focus on teaching leadership skills.

On behalf of the CMHA-CEI Board, Joe Brehler in the absence of Board Chair, Maxine Thome expressed how greatful and thankful CMHA-CEI is to have CEO, Lurie on board, and applauded her and her staff for the remarkable job that has done in the face of many obstacles and challenges that have been faced over the past year as we continue with the recertification of CCBHC, and embark on the wall breaking of the new Crisis Stabilization Unit; not to mention the lack of a dedicated Executive Administrative Assistant for almost 8 months this year.

CEO, Lurie thanked the CMHA-CEI Board and assured them that she will work on the noted items acknowledging that she could not have been as successful with the incredible team of leaders, commenting that she is so fortunate to work with such a committed and dedicated team of Directors, Supervisors, Managers, supportive and knowledgable board members, and County Commissioners, noting that we are already missing Joe Brehler, who will retire 12/31/24 from the CMHA-CEI Board of Directors after 20 years of dedicated and committed service.

Board Member, Raul Gonzales mentioned the recent 2024 Award Winning exemplary staff acknowledgement received by CMHA-CEI from CMHAM.

Dianne Holman, CAC Chair reported that the September 30, 2024 meeting included a presentation by Bradley Allen, Quality Coordinator, and Tonya Seely, Quality Improvement Specialist of the FY24 executive summary and CMHA-CEI Needs Assessment, reporting that The Needs Assessment was almost finalized, and a copy will be published on the CMHA-CEI website in the next few weeks.
