New Expense Contract: Right At Home - Brighton (CMHA-CEI)

Mary Clissold presented a request to approve Right At Home – Brighton as a provider for Community Living Supports services. Consumers and their families are able to choose a provider from an approved panel.

MOVED by Kay Pray and SUPPORTED by Paul Palmer that the Program and Planning Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, Ingham Counties authorize CMHA-CEI to enter into a contract with Right at Home in Home Care & Assistance, 5865 Whitmore Lake Road, Ste. D, Brighton, MI, to purchase Community Living Supports (CLS) and respite, and pay per the rate schedule listed below for the period of 8/1/13 – 12/31/15:

New Expense Contract: Forster Woods Adult Day Center (CMHA-CEI)

Mary Clissold presented a request to approve Forster Woods Adult Day Center as a day program provider. The approval of this day center was requested by a consumer who wishes to attend day programming in the Williamston area.

MOVED by Paul Palmer and SUPPORTED by Kay Pray that the Program and Planning Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, Ingham Counties authorize CMHA-CEI to enter into a contract with Forster Woods Adult Day Center, 4656 North Meridian Road, Williamston, MI to purchase Community Living Supports (CLS) and respite and pay up to the following rates: hourly rates dependent on Level of Care of \$14.12 and \$16.12 with respective holiday rates of \$21.18 and \$24.18 for the period of 08/01/2013- 9/30/2014.

Fiscal Year 2012-2015 Strategic Plan (CMHA-CEI)

Al Way presented the 2012-2015 Strategic Plan developed over the past year through multiple discussions of the Program & Planning Committee and the full Board.
