#### **BUSINESS ITEMS:**

**New Revenue Contract: Ingham County** 

KC Brown presented a new revenue contract to provide on call mental health screening services to Ingham County.

Joe Brehler joined the meeting at 5:32 p.m.

On call services are described in the contract as occurring from, "Friday, 5 pm through Monday morning 8 am, including recognized Ingham County holidays, with either on site or telephone consultation, as needed." The revenue source that supports this contract is Ingham County. This contract covers the administrative costs incurred with the operation of this program. On call Mental Health Therapists will be responsible for carrying a pager one weekend per month, rotating the month between four on call employees, and respond during the days and hours described above. Services are described as a screening assessment on each referred individual identified as having a need to meet with a Mental Health Therapist. The reason an individual is referred can be due to several Mental Health issues, such as, but not limited to:

- -Identification by Detention Officer as high risk for self harm due to past history
- -Suicidal threats, self harm threats
- -Self harm, harm to others
- -Symptoms of depression, crying, isolation, past history of depression
- -Requests from family or significant others
- -Behaviors that are considered outside of the normal range of behavior

CMHA-CEI also provides quarterly reports as a part of the contract, including information such as the number of assessments, hours, travel time, and diagnosis. Discussion ensued regarding assessment procedures, locations, and prescriptions. The Program and Planning Committee inquired about assessment coverage for Monday through Friday from 5 pm to 8 am. The Corrections Assessment and Treatment Services (CATS) program operates within the Ingham County Jail

routinely during the week. If the matter is urgent the individual is brought to Crisis Services.

#### **ACTION:**

MOVED by Kay Pray and SUPPORTED by Stephen Manchester that the Program and Planning Committee recommends that the Board of Directors of the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) authorize CMHA-CEI to enter into a new revenue contract with Ingham County to provide emergency psychiatric screening services to the Ingham County Jail for the period of January 1, 2016 through December 31, 2016 and receive \$30,000 per year for those services / goods.

# <u>Letter of Commitment Request: Michigan Department of Health and Human Services</u>

Sara Lurie presented a request to submit a letter of commitment from the CMHA-CEI Board of Directors. In this proposed project, if selected by Michigan Department of Health and Human Services (MDHHS) to participate, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will serve as the "Backbone" for the Community Health Innovation Region (CHIR). As such, CMHA-CEI will fulfill the role as fiduciary, financial manager and contract manager with multiple agencies contracted to fulfill specialized roles in the project. In addition the CMHA-CEI Board of Directors would initially serve as the governance body for the CHIR while a CHIR Steering Committee is established, infrastructure developed, and a permanent governance structure is put into place. If CMHA-CEI is selected by MDHHS, more information regarding the commitment term and funding will be available.

#### **ACTION:**

MOVED by Joe Brehler and SUPPORTED by Kay Pray that the Program and Planning Committee recommends that the Board of Directors of the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) authorize CMHA-CEI to provide a letter of commitment to the Michigan Department of Health and Human Services to fulfill the role of "Backbone" and to provide temporary governance to the Community Health Innovation Region should our region be selected to participate in the State Innovation Model Test.
