<u>CALL TO ORDER:</u> The meeting was called to order at 6:08 p.m. by Chairperson, Carol Koenig.

PREVIOUS MEETING MINUTES

MOVED by Carol Koenig and SUPPORTED by Paul Palmer to approve the meeting minutes of March 17, 2016 removing the Committee recommendation language, only including the Board of Director action language.

MOVED by Paul Palmer and SUPPORTED by Raul Gonzales to adopt the meeting agenda adding item 1, entitled: Conference Report, under New Business, allowing Board members who attended the MACMHB Spring Conference in Dearborn, MI on behalf of CMHA-CEI an opportunity to share information (either orally or in written form.) PUBLIC COMMENT ON AGENDA ITEMS:

Stephanie Tighe distributed copies of the Charter House brochure as a follow-up to last months' Board of Director's meeting.

MID-STATE HEALTH NETWORK (MSHN) UPDATE:

Kay Pray announced that strategic planning is going forward. To add to what Kay Pray has already stated, Joe Brehler elaborated that the strategic planning retreat included presentations in the morning and breakout sessions in the afternoon. There was no additional information to report at this time.

CHIEF EXECUTIVE OFFICERS (CEO) REPORT:

Pat Miller who has been an employee of CMHA-CEI for over 41 years and has a rich and long history assumed new responsibilities as of April 20, 2013 as the Wardcliffe Autism Clinical Supervisor provided an update of the Wardcliffe Abilities Center. Ms. Miller's presentation highlighted the following:

- Michigan Students with School ASD Eligibility 2014
- General Statistics
- 2014 Special Ed. Counts Students with Autism Spectrum Disorder
- CEI CMH BHT/ABA Data currently 126 enrollees
- CEI Evaluation Results
- As of January 1, 2016, Applied Behavior Analysis services are now covered for individuals diagnosed with ASD up to age 21 who meet eligibility and medical necessity criteria and other Medicaid ABA Key Changes
- What Services are Reimbursed
- CEI Collaborations
- Wardcliff Autism Evaluation Center
- SLP & OTR
- New Projects on the Horizon
- Project Search

In addition, Ms. Miller indicated that due to the fact that the travel has been reduced, the center now has two speech and two occupational therapist covering services.

Ms. Miller fielded the following questions:

- Where is care provided if individuals are unable to attend appointments during school hours? Ms. Miller indicated that there are other off-site locations where services are provided which include, but are not limited to residential options, MSU Early Learning Center.
- What happens to the individuals who do not qualify for autism spectrum disorder? Ms. Miller indicated that the psychiatrist meets with them and recommend resources and refer them for other testing.

In closing, Ms. Miller announced that Barb Groom, Autism Coordinator/Wardcliff Abilities Center/CSDD was scheduled to present with her this evening, however, with the announcement this morning during the CEC that Ms. Groom was the winner of the 2016 Myrtle Yoshinaga Clinical Excellence Award she decided to give her the night off. The Board of Director's unanimously agreed that this was in order.

With a heavy heart, Sara Lurie, Chief Executive Officer addressed the article published in the Lansing State Journal regarding a recent suicide by a Charlotte area youth. Discussion ensued. There was a request made to the Chair of the Board of Directors to spearhead a Suicide Prevention/Emergency Services Access workgroup soliciting members of the Board of Directors to explore challenges and ideas surrounding this topic.

In addition, Sara Lurie referenced page 19, entitled: Denials Reported by CMHSP of the board packet which documented that between March 1, 2016 and April 4, 2016, CMHSP's reported 1110 instances of psychiatric inpatient admission denials for 144 consumers. This is an average of 7.7 denials per consumer, however some consumers were denied as many as 20 times, or more. Of the total number of consumers denied admission, 29% are children/minors and 71% are adults. The most common reason for denial reported is At Capacity (73%), with the second most common reason reported being Patient Does Not Fit Milieu and No Call Back/No Response at 9% each. All other reasons documented make up just 8% of the denials.

Sara commented that in our pursuit of the CCBHC model, we are hopeful that this will help us expand and allow us to more fully serve the community.

Discussion ensued regarding the history of this family established trust and the request to add an additional signatory requirement, which Mr. Brehler informed address during the Finance Committee meeting on May 11, 2016.

Building and Sites Committee

John Peiffer, Properties and Facilities Manager reported that we are now anticipating a July 1 or August 1 start date. There are two items that could delay the July 1 date:

1) City of Lansing approval on the sanitary sewer relocation and associated change to the existing easement. Mr. Peiffer reported that we anticipate City of Lansing Counsel will take a formal vote on the item on June 13th. We are also waiting on the City Public Works Department to review the plans and file the paperwork with the State of Michigan DEQ.

2) Ingham County Bond Approval Process Update

This past week two meetings took place with approvals from both the Ingham County Finance Department and Board of Commissioners. The item will go to the full Ingham County Board next week on May 24th. Once approved, the matter is then turned over to the Ingham County Building Authority to hire a Bond Attorney and begin the process to sell the bond.

In addition, it was noted that Ingham County rolled into the bond another project for \$2.3 million to renovate space for the Health Department and it is possible that the interest rate on the bond will be as low as 2.5%.

Stacia Chick commented that this reflects a \$65,000 savings which will help the budget going forward.

In addition, John Peiffer reported that the Communications team is working on a full communication plan with Sara Lurie and have prepared a communication matrix and schedule for a number of target audiences and vehicles to be utilized for future communications.

MAMCHB Spring Conference Updates

Ethical Tension: Recipient Rights vs. Clinical Treatment

Kay Pray attended the Ethical Tensions: Recipient Rights vs. Clinical Treatment and described the complex relationship that exists between recipient rights issues and being able to provide clinical treatment that best meets the consumers need. Ms. Pray explained that one of the major tensions that are encountered between recipient rights issues and clinical treatment is when a treatment plan calls for placing restrictions on a consumer's freedom of movement or limiting access to their personal property. This workshop focused on the complex relationship of recipient rights issues vs. clinical issues, as well as provided direction on how to resolve these issues and still provide effective treatment as well as provided an understanding of how recipient rights issues impacts clinical treatment decision by brainstorming and using actual case scenarios.

Ms. Pray reported that she found this workshop to be very interesting and many of the attendees were quite informed.

Police and Community Commonality

Board of Directors Meeting Minutes (aye) May 19, 2016 The group that Chairperson, Carol Koenig participated in focused on what Michigan police officer families and community families have in common. At the end of the day, the findings were both just want their love one to come home at night.

Behavorial Health

Mr. Manchester reported that 80% of the discussion was regarding policy and legislation and that he is pleased at what he heard regarding behavioral health and integration. There was an overarching theme to pull together in serving our clients. The understanding of wellness as a framework for, and outcome of, integration; and promoting wellness and recovery works. Mr. Manchester stated that although Michigan is still an outlier, wellness as a framework for integrating, mental health and substance abuse, and behavioral health with primary care, as a way to decrease early mortality, improve health, homelessness and well-being.
