Mid-State Health Network Update:

Kay Pray reported that Mid-State Health Network did not meet the first Tuesday of November.

Joe Brehler added that he, Sara Lurie and Ericanne Spence met with the SUD providers earlier today regarding the conversion to FFS as well as voiced concerns regarding this change. Many expressed that they have loss staff since the announcement by MSHN. Another area of discussion was the surplus of PA2 money.

CEO Report

Sara Lurie, Chief Executive Officer introduced Shana Badgley as the new Director of Adult Mental Health Services for CMHA-CEI.

Shana was previously the Coordinator of the Mason Rural Outreach Program and brings to the Director position over 18 years of experience working within our organization at Bridges Crisis Unit, Eaton County Counseling Center, Community Care Clinic, Team 1 Case Management, and Mason Rural Outreach Program. She is a recognized leader in the state in the implementation of the evidence-based Dialectical Behavior Therapy treatment model; has a strong working knowledge of the field of adult mental health services; proven administrative and supervisory skills; the ability to work, cooperatively, with internal and external stakeholders; a commitment to hard work and initiative; and a dedication to the mission of this organization.

- Ph 1 = Design Development,
- Ph 2 = Construction Oversight Administration,
- Ph 3 = Close out, provide as built drawings to owner.
- 3). The Bond process is still progressing.
- 4). CMHA-CEI will be attending the next Ingham County Building Authority Meeting scheduled for November 2, 2016 at 2 pm. An update will be provided at the next CMH Board Meeting.

Announcement

Paul Palmer announced that the State of Michigan will be launching a disability savings program, which is the most substantial reform for people with disabilities since the Americans with Disabilities Act in 1990. MiABLE (Michigan Achieving a Better Life Experience) program allows individuals with disabilities and their families to save for the future without fear of losing any disability benefits. Program highlights include:

- MiABLE accounts allow for savings up to \$100,000 without losing other financial disability benefits.
- Funds are not taxed upon withdrawal if used for a qualified disability expense.

- Qualified expenses include: education, housing, transportation, employment training and support, assistive technology, health, financial management services, legal fees or funeral/burial expenses.
- There may only be one individual per ABLE account, but anyone can contribute into it.
- Disability onset and diagnosis must occur prior to age 26.
