## **COVID-19 Vaccination FAQs**



As you may have heard, opportunities for COVID-19 vaccination are beginning to become available for certain priority groups! As a designated priority group in the current phase of the State of Michigan's vaccination plan, many consumers living in AFC homes have been or will soon be contacted regarding recieving their first dose of the COVID-19 vaccine.

CMHA-CEI is reliant on local health departments and federal programs that are allocated COVID-19 vaccines and this means we are coordinating with multiple local agencies and programs with differing supplies and processes.

While it may seem confusing at times, we are doing our best to navigate and communicate with our consumers and staff. Stay tuned for more information!

#### When will I be able to get vaccinated?

The COVID-19 vaccination landscape is ever changing depending on each county's supply and their need to prioritize who receives it based on their supply. If supplies are low, local health departments may cancel or delay scheduling vaccines. We do not yet know when the local health departments will make vaccinations available more broadly to consumers who are not living in AFC homes, but we will continue to update as we get more clarity. We will continue working with our in-house pharmacy, Ascension, to secure vaccines, however this may yet be weeks to months away.

#### How many doses do I need for the vaccine to work?

Vaccinations are two doses and you must get both doses from the same manufacturer, 3-4 weeks apart, dending on the type.

## Do I need to keep wearing a mask after I get vaccinated?

Yes. You should continue to wear masks, social distance from those not in your household and wash your hands, even after receiving vaccine.
