# **BUSINESS ITEMS:**

<u>New Revenue Contract: Infant and Early Childhood Mental Health</u> <u>Consultation (IECMHC) Services in Home Visiting</u>

Gwenda Summers presented this new contract with the State of Michigan regarding CEI's early intervention consultation. The State needs folks with relevant education and experience to consult with their home visitors on early intervention services.

# ACTION:

MOVED by Joe Brehler and SUPPORTED by Tim Hanna that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to enter into a new contract with MDHHS to provide a Mental Health Therapist to provide IECMHC Consultation for the retroactive period of October 1, 2021 to September 30, 2022 and receive \$21,073 for those services.

<u>New Expense Contract: Genesee Health Systems - COFR Agreement</u> Karla Block presented this item for a general COFR agreement between CEI and Genesee County Health System.

Tim asked for a brief description of what a COFR is and whether we use them often? Karla said this is one of the ways the county in which a person lives is still responsible for cost of services when using CEI services when outside of the tricounty area, and we do use COFRs fairly often.

# New Expense Contract: Eisenhower Center, Mariah Hall AFC

Karla Block presented this new contract for AFC supports. An individual lost his AFC placement while receiving services out of state. The contract will help to maintain services while finding a more appropriate AFC home. Karla is unsure how long the it may take to find a more permanent placement.

# ACTION:

MOVED by Al Platt and SUPPORTED by Joe Brehler that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to enter into a new contract with Eisenhower Center, Mariah Hall AFC to purchase specialized residential services with the per diem rates base on clinical need of:

- H2016 and T1020 (\$555 base rate) with 16 hours of 1:1 paid at \$26 per hour = Total of \$971.00 per day
- H2016 and T1020 (\$555 base rate) with 8 hours of 1:1 paid at \$26 per hours = Total of \$763.00 per day
- H2016 and T1020 = \$555

The contract period will have a retroactive effective date of 9/27/2021, and contingent upon full licensure and HCBS approval, will continue through September 30, 2022.

# ACTION:

MOVED by Al Platt and SUPPORTED by Joe Brehler that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to enter into a new contract with Packard Specialized Residential AFC to purchase specialized residential services with the per diem rate of \$350 for the AFC per diem rate providing Personal Care (T1020) and Community Living Support (H2016). The contract period will have a retroactive effective date of 10/1/2021, contingent upon full licensure and HCBS approval and will continue through September 30, 2022.
